## **A.VISION STATEMENT**

- To provide a forum to establish a mutually beneficial link between the alumni, faculty, staff and students of the institute.
- To enable the alumni to participate in activities which would foster general development of the institute as well as the personal development of the alumni.
- To keep the alumni aware of scientific and technological developments of national importance.
- To help the alumni with their technical problems and also seek their help in rendering technical assistance to students, faculties, and staffs of the institute.
- To sponsor institute prizes and scholarships, render financial aid to deserving students of the institute, and for the development of institute infrastructure.
- To contribute towards the welfare of the alumni and IIITA students, faculty and staff members.
- To take an initiative for creation of PAN IIIT Alumni India (similar to PAN IIT Alumni India) as also suggested by Ministry of Education, GOI.

## **B.CHAPTERS**

- 6 chapters are currently active; Delhi-NCR, Mumbai/Pune, Hyderabad, Bengaluru, Europe/UK and the USA.
- The chapters are responsible for periodically bringing together the alumni in their respective geographical locations.
- The chapters are envisioned to provide career services, CV building to alumni in their respective geographical locations.
- The chapters are envisioned to help new alumni in settling down in their respective geographical locations.
- The chapters are envisioned to provide job/academic opportunities to the alumni in their respective geographical locations.
- The chapters are envisioned to harness their networks with establishments/corporate in their respective geographical locations for hiring graduating batches of the institute.
- The chapters are envisioned to provide or serve as conduits between the institute and the alumni in their respective geographical locations.
- The chapters are to lead mentor programs that pair outgoing students with alumni in similar career fields.
- The chapters are envisioned to maintain their local contingency funds. A committee of IIITA officials and EC members of the Chapters will formulate the rules and regulations to maintain the funds generated by each chapter.
- The chapters are envisioned to provide hosting facilities in their respective geographical locations for visiting officials of the institute.
- The chapters are responsible for publicity and awareness of the institute in their respective geographical locations through their

- **individual Chapter Website** whose link will also be present on the IIITA Alumni Website.
- The chapters are to identify and help in recruiting potential faculty members for the institute from the universities located in their respective geographical locations.
- A New chapter, based on minimum strength of alumni in a City and its nearby area/regions and the also interest of the alumni there, may be established in future.
  (In our current "Hyderabad" Chapter, the alumni from Hyderabad as well as Chennai are part of the same group. Same criteria are followed for other Chapters to keep number of Alumni Chapters manageable).
- A chapter will adopt suitable Bylaws for its functioning and ensuring its strong connectivity with the Institute i.e. IIITA and also decide mode of elections of a Chapter's office bearers as per the need.
- In future, the Alumni Chapters may plan to organize Chapter-wise Alumni Meet with invitation to the concerned officials from their Alma Mater i.e. IIITA.
- The chapters can offer discounts on hotels, rental cars, restaurants, and other services in their respective geographical locations.
